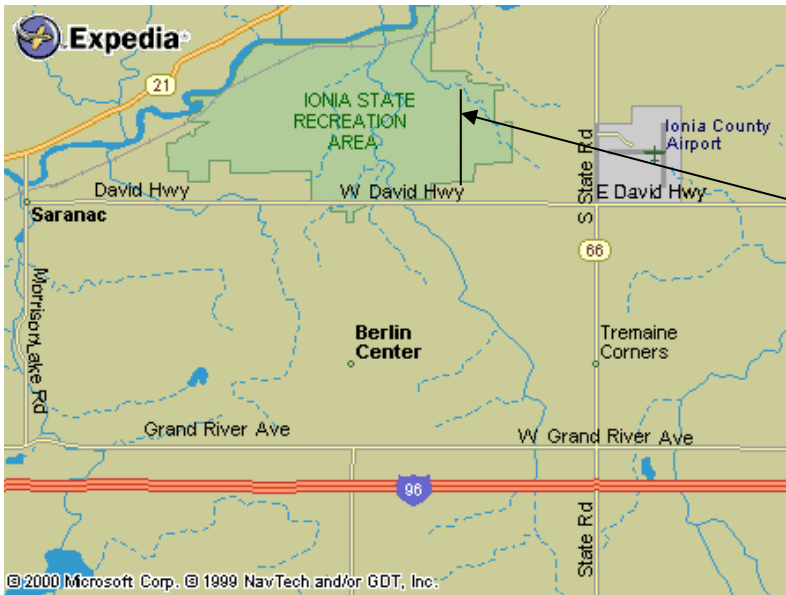

Directions to the Grounds

Field trial grounds are located within the Ionia State Rec. Area , between Ionia and Interstate 96 just west of State Route M66.

A Michigan Motor Vehicle State Permit is necessary to park on the grounds.
Permits may be purchased at the grounds.

Take M66 to David Highway-west to Harwood Rd. north (about a mile) to the trial grounds staging area/horse barn/activity center.



Field Trial grounds are located within the Ionia State Recreation Area, between Ionia and Interstate 96 just west of State route M66.

Take M66 to David Highway west to Harwood Rd. north (about a mile) to the trial grounds staging area / horse barn / activity center.
