#### **ELIGIBILITY OF DOGS FOR RATING TESTS:**

- A. Any Weimaraner with an individual AKC number, including an AKC Limited Registration, or an ILP number who has obtained the age of six (6) months on the first day of the tests may compete for any or all of the ratings offered.
- B. Ratings Tests are open to all Weimaraners whose owners and co-owners are all members of the Weimaraner Club of America in good standing.

  Any member with an outstanding balance owed to the WCA may not compete in any WCA event until the balance is paid in full.
- C. Spayed bitches or castrated males may compete for and receive ratings titles.
- D. Weimaraners that have disqualifying faults (as listed in the current standard for the breed) shall be eligible to compete for and receive ratings provided they are spayed or castrated. PRIOR to being entered in a ratings test, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or castrated and receive a DQF Number. All Weimaraners with AKC ILP numbers are allowed to participate without applying to the National Office. To receive a DQF Number owners must present a copy of the dog's AKC Registration Certificate or AKC recognized foreign registration certificate, and a copy of the dog's spay or castration verification from their veterinarian to the WCA National Office, PO Box 489, Wakefield, Rhode Island, 02880.

Single course with bird field used at all Shooting Ratings levels
Quail and/or Chukar and/or Ducks and/or Pigeon will be used in all stakes
No one is permitted in the bird fields until after the last brace has completed.
Only dogs that qualify on land will go on to the water retrieves, in the same order.

## Blank Pistols, Blaze Orange, and Tracking Collars

Blank pistols as approved by the AKC shall be fired in all levels.

Official gunners will use 20 gauge or larger shotguns.

ALL PARICIPANTS MUST WEAR BLAZE ORANGE.

Highland Recreation Area, Silo Course, is located on Livingston Road between Pettibone Lake Rd. and Beaumont Rd. Click here for Google Maps pin From the west: Take US-23 North to M-59 East. Harvey Lake Rd. is approximately 10 miles East of US-23. Turn right (South) on Harvey Lake Rd. until it dead ends at Livingston Rd. Left (East) on Livingston Rd. Trial grounds are on the right (South) side after Pettibone Lake Rd.

<u>From the East</u>: M-59 to Duck Lake Rd. Turn left (South) to Livingston Rd. Turn right (West) onto Livingston Rd. Trial grounds are on the left (South) side after Beaumont Rd.

**THE LAND PORTION OF RETRIEVING RATINGS** will be held at a private residence within 10 miles of the Highland Grounds: 5429 Edgar Rd, Clarkston MI 48346. Upon the completion of land series, participants will be guided to the water series location.

### HIGHLAND GROUNDS INFORMATION

The SMWC is using State of MI grounds for this event. Please use designated areas for camping & parking.

A MI DNR permit is required for every motor vehicle to park on the grounds, regardless of if you are camping or not. Permits may be bought at the grounds. The forms will be located on the green stand by the guard rail. The DNR will be actively checking for compliance with this state requirement.
