Highland Recreation Area, Silo Course, is located on Livingston Road between Pettibone Lake Rd. and Beaumont Rd. Click here for Google Maps pin

From the west: Take US-23 North to M-59 East. Harvey Lake Rd. is approximately 10 miles East of US-23. Turn right (South) on Harvey Lake Rd. until it dead ends at Livingston Rd. Left (East) on Livingston Rd. Trial grounds are on the right (South) side after Pettibone Lake Rd.

<u>From the East</u>: M-59 to Duck Lake Rd. Turn left (South) to Livingston Rd. Turn right (West) onto Livingston Rd. Trial grounds are on the left (South) side after Beaumont Rd.

# GROUNDS INFORMATION

The SMWC is using State of MI grounds for this event. Please use designated areas for camping & parking.

A MI DNR permit is required for every motor vehicle to park on the grounds, regardless of if you are camping or not. Permits may be bought at the grounds. The forms will be located on the green stand by the guard rail. The DNR will be actively checking for compliance with this state requirement.
