approximately 3.5 miles. The Course 2 parking lot is on the left behind the historic Sessions Schoolhouse.

GROUNDS INFORMATION

The SMWC is using State of MI grounds for this event. Please use designated areas for camping (on Course 1 only) & parking.

A MI DNR permit is required for every motor vehicle to park on the grounds, regardless of if you are camping or not. Permits may be bought at the grounds.
